## Invitation for Bid #13-0703 for Security Upgrades to the IST Building

Scope of Work: The primary scope of this Project is to install security upgrades to the County's IST Building. The scope of work includes, but is not limited to, installation of: replacement of existing (and installation of new) CCTV cameras; replacement of existing (and installation of new) card readers (and related new control panels); installation of new duress alarms (and related control panels, annunicator panels and strobes); changes to door hardware at selected existing doors. The existing OnSSI capacity is sufficient to accommodate the scope of this Project and no upgrades are required. The required OnSSI licenses for the added cameras, including the one year license upgrade and all programming for these two new cameras will be provided direct by the Owner. The intended end result of this Project when complete, is fully functional, fully programmable, integrated Security Management Systems.
